I.D. NOTE / MEMORANDUM

Sub: Public Services – Filling up of vacancies in the posts of Driver (LMV) Grade-III under absorption quota – Service particulars of Cleaner, Multi-Tasking Staff (General/Security/House-keeping) and Bus Attender – Called for.

It is proposed to fill up the vacancies in the posts of Driver(LMV) Grade-III in Level-2 of Pay Matrix under absorption quota by absorption from among the grades of employees as indicated below :-

SI. No.	Name of the post to be filled by absorption	Eligiblity of employees for absorption
1.	Driver(LMV) Grade-III	Cleaner, Multi-Tasking Staff (General), Multi-Tasking Staff (Security), Multi-Tasking Staff (House-keeping) and Bus Attender who have put in 3 years of regular service in the grade and have passed 8 th Standard and possessing a valid LMV Driving Licence with experience of driving motor car for atleast 3 years.

The selection will be subject to passing the competency test in (a) Driving, (b) Traffic regulation , (c) Location of faults and carry out minor running repairs including change of wheels, conducted by the Transport Department, Puducherry.

- 2. All Heads of Departments/Offices are, therefore, requested to furnish the service particulars of the eligible and willing employees in the grades of Cleaner, Multi-Tasking Staff (General), Multi-Tasking Staff (Security), Multi-Tasking Staff (House-keeping) and Bus Attender who have put in 3 years of regular service in the respective grades as on 1-1-2022, as in the Proforma-I (enclosed) along with the following certificates.
 - (a) Integrity Certificate
 - (b) Certificates to the effect that:
 - (i) the official concerned is not under suspension;
 - (ii) no disciplinary proceedings are pending / being contemplated against the official concerned;



- (iii) no prosecution for a criminal charge is pending or no sanction for prosecution has been issued or no decision has been taken to accord sanction for prosecution against the official concerned;
- (iv) no investigation on serious allegations of corruption, bribery or similar grave misconduct is in progress either by the CBI or by any other Agency (Departmental or otherwise) against the official concerned;
- (v) Expression of willingness in writing (as per Proforma-II) for being considered for absorption to the post of Driver (LMV) Grade-III and willing to work in any Department/ Office in any of the region of the U.T. of Puducherry;
- (vi) Attested xerox copies of certificates in support of the particulars furnished in respect of Educational and Technical Qualification.
- 3. Accordingly, the particulars of eligible & willing employees in the above mentioned grades who have completed 3 years of regular service in the respective grades as on 1-1-2022 should be furnished by the Head of Departments in complete shape for the entire department i.e. duly including the sub-ordinate offices under their control in Puducherry and outlying regions, on or before 09-09-2022.
