ORDER:

The Central Civil Services (Classification, Control and Appeal) Rules, 1965 has been amended in the year 2003 to the effect that an order of suspension made or deemed to have been made under rule 10 of the said Rules shall be reviewed by the authority competent to modify or revoke the suspension, before expiry of 90 days from the date of order of suspension, on the recommendation of the Review Committee constituted for the purpose and pass orders either extending or revoking the suspension. Accordingly, the Government of India, Ministry of Personnel, Public Grievances and Pensions (Department of Personnel & Training), New Delhi in their Office Memorandum read first above have communicated necessary instructions to be followed in regard to constituting Review Committees to review the suspension cases.
