**C I R C U L A R**

Sub: Public Services - Deputation of Government employees to the organizations funded and controlled by the Government - Instructions - Issued.

Instances have been brought to notice that difficulties are experienced in filling up of vacant posts on deputation basis in the autonomous institutions / societies and other bodies owned or substantially funded by the Government on the basis of the extant instructions issued vide Circular No.A.35011/1/2002/DP&AR/SSI(1) dated 30.12.2002 of the D.P. & A.R. (Personnel Wing), Puducherry. Even after repeated circulation of vacancies, the deputation posts remain vacant for months together and in many cases, officials are not willing to apply for the deputation posts resulting in futility of the entire exercise and dislocation of the smooth functioning of the organization concerned.

2. As provided under F.R.110, "no Government servant may be transferred to foreign service against his will provided that this sub-rule shall not apply to the transfer of a Government servant to the service of a body, incorporated or not, which is wholly or substantially owned or controlled by the Government". It is therefore clear that in the case of transfer of any Government servant to foreign service in any organization including the Panchayat Raj institutions in the Union Territory of Puducherry, necessary powers to do so are available under the proviso to F.R. 110(a) and the consent of the Government servant is not necessary for transfer to such institutions/ organizations.

3. It is therefore brought to the notice of all concerned that the instructions issued vide circular cited in para (1) **shall stand modified** to the extent that the existing procedure of inviting applications from eligible Government employees for transfer to foreign service in the organization partially or substantially funded by the Government of Puducherry is to be dispensed with. As soon as the requisition is received from the borrowing authority, the lending Authority may draw a panel of not less than three eligible officials in the order of preference fulfilling the requisite qualifications prescribed in the Recruitment Rules to the deputation post and issue necessary orders of deputation on usual terms and conditions after duly obtaining the consent of the Competent Authority.



4. These instructions will come into force with immediate effect.
