2. The Drivers are instructed to appear for the Test along with vehicle, original driving licence, Department Identity card and necessary tools for

- (i) Verification of Driving Licence
- (ii) Test on Driving Signals, knowledge of traffic regulations, etc.
- (iii) Ability Test on identifying of the faults, carrying-out of minor running repairs, mechanism and able to clear Carburetor, Plug, etc.
- (iv) Practical Test on Driving of vehicle.

3. The Drivers who fail to produce the original driving licence for verification will not be allowed to appear for the above Test.

4. The Drivers must abide by such instructions which may be given by the Supervisors of the test. If any Driver fails to do so or indulge in disorderly or improper conduct, he will render himself liable for expulsion from the test and or such other punishment as the Government may deem fit to impose.
