- 2. They will, draw pay in the Level 2 of the Pay Matrix (Pre-revised Pay Band Rs. 5200-20200 Grade Pay Rs. 1900/-) plus usual allowances admissible under rules.
- 3. They should also work as Cashier, if they are so directed by the Head of Department / Office, for which they should furnish necessary Fidelity Bond / Cash Security.
- 4. The promotees should pass the prescribed departmental tests and Typewriting Exam (Lower Grade) within two years from the date of promotion.
- 5. They shall report for duty on or before <u>03/01/2025</u>, failing which it will be presumed that he/she has declined the promotion offered and he/she will not be considered for promotion for a period of one year or next DPC, whichever is later, from the date of issue of the promotion order.
