Sub: Public Services – Absorption to the post of Driver (LMV) Grade-III -
Orders – Issued.

2. They will draw pay in the Level 2 of Pay Matrix and allowances as admissible under rules in force from time to time.

3. The appointment is subject to the production of Certificate of Medical Fitness issued by the Competent Medical Authority.

4. They shall report for duty on or before 17-08-2026, failing which it will be presumed that they have declined the offer and they will not be considered for absorption for a period of one year or next DRC, whichever is later, from the date of issue of this Order.

5. They shall be relieved immediately without waiting for substitute. In case, any of the candidate declines his absorption as Driver (LMV) Grade-III, the same may be reported to this Department without fail. Request for change of place of posting will not be entertained.

6. In case, any disciplinary proceedings are pending / contemplated against any of the candidates, the absorption orders may not be served to them and the fact may be intimated to this Department.
