MEMORANDUM

Sub: Public Services – Promotion and Posting of Multi Tasking
Staff as Lower Division Clerks – Orders – Issued.

The Multi Tasking Staff mentioned in the Annexure to this Memorandum are promoted as Lower Division Clerks on Regular basis and posted in the Departments / Offices noted against them with immediate effect.

2. They will draw pay in the Level 2 of the Pay Matrix (Pre-revised Pay Band Rs. 5200-20200 Grade Pay Rs. 1900/-) plus usual allowances admissible under rules.

3. They should also work as Cashier, if they are so directed by the Head of Department / Office, for which they should furnish necessary Fidelity Bond / Cash Security.

4. The promotees should pass the prescribed departmental tests and Typewriting Exam (Lower Grade) within two years from the date of promotion.

5. They shall report for duty on or before, 31/07/2026 failing which it will be presumed that he/she has declined the promotion offered and he/she will not be considered for promotion for a period of one year or next DPC, whichever is later, from the date of issue of the promotion order.

6. The Heads of Department/Offices concerned are requested to relieve the officials without waiting for substitute and request for retention / modification of promotion orders will not be entertained.
