Master's Degree of a recognized University in any subject other than Tamil or English, with English medium and Tamil as a compulsory or elective subject or as the medium of examination at the Degree level.

(or)

Master's Degree of a recognized University in any subject other than Tamil or English, with Tamil and English as compulsory or elective subjects or either of the two as a medium of examination and the other as a compulsory or elective subject at Degree level.

- (i) Recognized Diploma/Certificate Course in Translation from Tamil to English or vice-versa from an Institute / University recognized by Government of India / UGC.
- (ii) Two years experience of Translation work from Tamil to English and vice versa in Central or State Government Offices including Government of India Undertaking.
