In the G.O first read above, it has been decided that this Administration may conduct direct recruitment to all the Non-Gazetted Group 'B' and "C' posts irrespective of the Grade Pay attached to the post without making any reference to the Union Public Service Commission.

2 Now, the Secretary, Ministry of Personnel and Public Grievances and Pensions, Department of Personnel and Training, New Delhi has informed vide reference second cited that Hon'ble Prime Minister in his address to the nation on the occasion of Independence Day announced that Government should discontinue holding interviews for recruitment for junior level posts in order to improve objectivity, transparency and to enable level playing opportunity to candidates from all sections of the society.

Accordingly, Lieutenant-Governor is pleased to order that holding of interview 3. shall be discontinued in all direct recruitment to the Non-Gazetted Group 'B' and 'C' posts (including erstwhile Group 'D' posts) in this Administration and it shall be made purely on the basis of written test/merit only.

4. This order is also squarely applicable to all Public Sector Undertakings/ Societies/Autonomous Bodies/ Boards, etc. under the control of Government of Puducherry.

This order shall take immediate effect and the notification issued for any direct 5. recruitment prior to this G.O. shall be completed as per the procedure envisaged in the said notification.
