Sub: Public Services – Reservation for Economically Weaker Sections (EWSs) in civil posts and services in the Government of Puducherry – Instructions – Issued.


Attention is invited to the G.O. cited on the above subject, wherein 10% reservation is extended to Economically Weaker Sections (EWSs) in civil posts and services in the Government of Puducherry.

2. Subsequently, the Council of Ministers in its meeting held on 01.08.2019 decided to rescind the G.O. ab-initio. Following this, a reference was made to Central Government under sub-rule (2) of Rule 56 of the Rules of Business of Government of Puducherry by the Hon'ble Lieutenant Governor, Puducherry.

3. In response to the said reference, the Ministry of Home Affairs, Government of India vide their Letter No.U-13034/02/2020-CPD(PUDU) dated 18.02.2020 has directed this Administration to continue with 10% EWSs reservation in civil posts and services as per O.Ms No.F.No.20013/01/2018-BC-II/Ministry of Social Justice and Empowerment, Department of Social Justice and Empowerment dated 17.01.2019 and No.F.No.36039/014/2019-Estt.(Res.)/Ministry of Personnel, Public Grievances and Pensions, DoPT dated 19.01.2019, with the approval of the Competent Authority.

4. Hence, all the Secretariat Departments / Heads of Department are directed to follow the instructions contained in the G.O. cited regarding reservation for EWSs in civil posts and services in the Government of Puducherry scrupulously.
