

OFFICE MEMORANDUM

Subject: Status of backlog vacancies reserved for Scheduled Castes, Scheduled Tribe and Other Backward Classes- Monitoring of Progress.

A copy of DoP&T's OM No. 36038/1/2014-Estt.(Res.) dated 13.11.2019 is enclosed regarding meeting to monitor the progress for filling up of vacancies reserved for SCs, STs and OBCs.

2. Additional Secretary (Estt.), DoP&T in the meeting held on 15.11.2019, reviewed the progress achieved in filling up of backlog vacancies reserved for Scheduled Castes, Scheduled Tribes and Other Backward Classes and took a serious view that MHA has not furnished the required data for period ending 2018 and 2019 so far.
3. As the information is required for the use of Parliamentary Standing Committees and for answering Parliament Questions, she directed that the required data for 2018 and 2019 be furnished within 3 days. If this requisite data is not furnished the same shall be communicated to their Hon'ble Minister.
4. It is requested that duly compiled and authenticated information in respect of your Division (including attached/subordinate offices under your administrative control) (as on 01.01.2018 and 01.01.2019) may kindly be sent to C&IC Division by 21.11.2019 in the enclosed proforma I & II, so that a consolidated information in respect of Ministry of Home Affairs could be sent to DoP&T without any further delay.
