Sub: Public Services – Counting of service rendered on notional basis for the purpose of financial upgradation under MACP Scheme – Clarification from Department of Personnel & Training, Government of India – Reg.

The Department of Personnel and Administrative Reforms (Personnel Wing), Puducherry had been receiving references from various Departments of this Administration seeking clarification as to whether the promotion granted on notional basis for various reasons can be reckoned for determining eligibility period for the purpose of financial upgradation under MACP Scheme. Accordingly, the issue was taken up with the Department of Personnel & Training, Government of India through the Ministry of Home Affairs, New Delhi for clarification.

2. Now, the Ministry of Home Affairs, New Delhi has conveyed the clarification given by the Department of Personnel & Training, Government of India, as follows:-

“It is clarified that the principles involved in the matter have general applicability for MACP Scheme as the question of stagnation in a particular Grade Pay or Pay Level for 10 years or in the intervals of 10, 20 and 30 years of service, would arise only after an employee starts drawing pay on assumption of charge of the post. Therefore, the period of notional promotion till assumption of charge of the post, does not count as qualifying service for determining eligibility of 10 years stagnation in a particular Grade Pay or Pay Level, for next financial upgradation, in standard hierarchy of Grade Pays / Pay Levels under MACPS.”

3. All the Secretariat Departments / Head of Departments are requested to take note of the above clarification for guidance and strict compliance.
