Ref: 1. This Department's I.D.Note/O.M. of even No. dated 07.12.2022

3.This Department's I.D.Note/O.M. of even No. dated 08.04.2025.

Kind reference is invited to the I.D.Note/ Office Memorandum first cited on the subject mentioned above, wherein the Cadre Controlling Authorities have been requested to launch a special drive to review and amend the Recruitment Rules for all the posts coming under their Control as per the DoPT guidelines immediately and complete the exercise before 28.02.2023. Further, in order to facilitate quick processing of the proposals detailed instructions have also been issued vide reference second cited. Again another reminder I.D. Note/ Office Memorandum was issued on 08.04.2025 on the same subject (3rd cited).

2. It is however noticed that, even after repeated instructions, Recruitment Rules for some of the posts in various Departments have not yet been amended as per the DoPT guidelines and are making recruitment/promotion as per the existing Recruitment Rules notified long ago.

3. In order to bring the RRs in conformity with the DoPT guidelines and 7th Central Pay Commission recommendations, Development Commissioner/ Commissioner-cum-Secretaries/ Secretaries are hereby requested to review and amend the Recruitment Rules for all the posts coming under their control immediately without further loss of time, if not done earlier.

4. It is also intimated that the Chief Secretary to Government has proposed to review the status of the RRs which are not in conformity with the latest DoPT guidelines and 7th Central Pay Commission recommendations in the first week of August 2026. Therefore, the Development Commissioner/ Commissioner-cum-Secretaries/ Secretaries are requested to furnish the current status of the RRs in the following format on or before 04.08.2026:
