ABSTRACT

CCD- Amendment to the "Business of the Government of Pondicherry (Allocation) Amendment Rules, 1985" – Constitution of Committee – Orders – Issued.

READ: (1) The Business of the Government of Pondicherry (Allocation), 1963.

(2) The Business of the Government of Pondicherry (Allocation) Amendment Rules, 1985.

Government of India, Ministry of Home Affairs notified the Business of the Government of Pondicherry (Allocation) Rules, 1963 on 01.07.1963 vide first read above and an amendment was substituted on 13.03.1985. It inter-alia deals with the entire business of the Government and classified & distributed between Departments mentioned in the Schedule.

2. From 1985 to till date, the Business of the Government of Pondicherry (Allocation) Amendment Rules, 1985, have not been updated or revised while many new Departments / Directorates have been created and established in the intervening period and are functional in the Union Territory without mention or necessary subject allocation, as required for conduct of Government business. Besides, the nomenclature of the UT had been changed from 'Pondicherry' to 'Puducherry'

3. Additionally, several new areas subjects and emergent innovative practices have emerged led by the Government of India such as 'Investment Promotion', 'Livelihood Mission(s)', 'Food Processing', 'Khadi & Village Industries Commission', 'MSME', 'AYUSH', 'Horticulture', 'Environment' and 'Climate Change' etc which need to be duly incorporated and also the redundant subjects get rid of from the list of Government Business.

4. The Lieutenant Governor, Puducherry is, therefore pleased to constitute a Committee with the following composition to examine and recommend suitable amendments to the Business of the Government of Pondicherry (Allocation) Amendment Rules, 1985, wherever necessary:-


