Public Services – Direct recruitments to the Non-Gazetted Group 'B' & 'C' posts existing in the Union Territory of Puducherry – Exemption from consultation with Union Public Service Commission – Orders – Issued.

(2) G.O.Ms.No.72 dated 26.04.2001 of the Department of Personnel and Administrative reforms (Personnel Wing), Puducherry.

ORDER:

In the order first read above, it was informed that the Union Public Service Commission need not be consulted while making direct recruitment to Group 'B' service or posts which is in the scale of pay the maximum of which is below ₹10,500/-.

- 2. Now, the Government of India vide their Notification No.39018/01/2012-Estt.(B) dated 24.07.2012 of Ministry of Personnel, Public Grievances & Pensions (DoPT), New Delhi has notified that the Union Public Service Commission have been exempted from making "direct recruitment to all Group 'B' (Non-Gazetted) and Group 'C' posts irrespective of the Grade Pay attached to the post."
- 3. Accordingly, it has now been decided that the Departments under the Government of Puducherry may conduct all direct recruitments to the Non-Gazetted Group 'B' & 'C' posts irrespective of the Grade Pay attached to the post without making any reference to the Union Public Service Commission.
- 4. The Chief Secretary to Government and the Secretaries to Government in-charge of the Departments concerned shall continue to be the Chairman for the Group 'B' & 'C' posts respectively, as communicated vide G.O. second read above.
