In exercise of the powers conferred by Part III and Part IV of the Schedule to the Central Civil Services (Classification, Control and Appeal) Rules, 1965, the Lieutenant-Governor, Pondicherry hereby specifies the authority mentioned in columns (2), (3) and (4) of the Table annexed to this G.O. respectively as the appointing authority, authority competent to impose all the penalties specified in rule 11 of the said rules and appellate authority to exercise the powers and perform the functions of such authorities in respect of the Group C and the Group D posts in the offices mentioned against each under column (5) of the said Table:


PROVIDED that the powers of the respective authorities shall be exercised subject to article 311 of the Constitution and the provisions of the Central Civil Services (Classification, Control and Appeal) Rules, 1965 and such other orders that may be issued by the Government of India from time to time in the matter:

PROVIDED FURTHER that in cases where the appointment was made by an authority higher than that specified in column (2) then, that authority will constitute the disciplinary authority under column (3) of the said Table in respect of major penalties and any appeal against the orders of such authority will lie to the next higher authority not below the rank of a Secretary to Government and where, however, the appeal is against the orders of the Lieutenant-Governor as the disciplinary authority, the appeal shall lie to the President.

2. This order supersedes all previous orders issued from time to time in this behalf:

Provided that such supersession shall not affect the previous operation of the orders so superseded or anything done or suffered thereunder and all proceedings already instituted may be continued and completed as if these orders have not been passed.
