#### **NOTIFICATION**

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India read with the Notification No.F.5/4/65-GP, dated 11<sup>th</sup> January, 1965 of the Government of India, Ministry of Home Affairs, New Delhi and in supersession of the Notification issued in G.O.Ms.No.2, dated 20<sup>th</sup> February, 2019 of the Chief Secretariat(Establishment), Government of Puducherry and published as supplement to the Gazette No.9 of the 26<sup>th</sup> February 2019, save as respects things done or omitted to be done before such supersession, the Lieutenant-Governor, Puducherry makes the following rules regulating the method of recruitment to the Group 'B' post of Assistant Director in the Puducherry Government Guest House, Chennai, Government of Puducherry, namely:-

- 1. Short title and commencement:-
- (i) These rules may be called the Government of Puducherry, Chief Secretariat (Establishment), Group 'B' post of Assistant Director (Puducherry Government Guest House, Chennai) Recruitment Rules, 2024.
- (ii) They shall come into force on and from the date of their publication in the Official gazette.
- 2. Number of post, its classification and Level in the Pay Matrix.- The number of the said post, its classification and the Level in the Pay Matrix attached thereto, shall be as specified in columns (2) to (4) of the schedule annexed hereto.
- 3. Method of recruitment, age limit and other qualifications.- The method of recruitment to the said post, age limit, qualifications and other matters relating thereto, shall be as specified in columns (5) to (13) of the said schedule.
- 4. Disqualification.- No person,-
  - (a) Who has entered into or contracted a marriage with a person having a spouse living; or
  - (b) Who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post.

Provided that the Lieutenant-Governor, may if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax.- Where the Lieutenant-Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing, and in consultation with the Union Public Service Commission relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving.- Nothing in these rules shall affect the reservations, relaxations in upper age limit and other concessions required to be provided for the scheduled castes, the scheduled tribes and other special category of persons in accordance with the orders issued by the Government from time to time in this regard.
