Sub: Observance of leave protest and rally on 25th April 2017 by certain section of employees - Disciplinary action - Reg.

In a press release it is stated that certain section of employees had proposed to observe of leave protest and rally on 25th April 2017 in support of Farmers agitation at New Delhi.

- In this connection attention is drawn to Rule 7(2)(i) of CCS (Conduct) Rules, 2. 1964 which clearly stipulate that mass absenteeism from work without permission is also clarified as 'strike' and no Government servant shall resort to any form of strike or coercion or physical duress in connection with any matter pertaining to his service or the service of any other Government servants. As per Government of India's decision (2) below Rule 7, any Government servant who resorts to such action mentioned above in violation of Rule 7 (ii) of CCS (Conduct) Rules, 1964 will be liable for disciplinary action. The unauthorized absence/strike of the employees shall be treated as break-inservice invoking the provisions of F.R.17-A.
- All Heads of Departments/Offices are requested to furnish a report of absentees, if any, on 25th April 2017 except those who were granted leave.
- They are also requested to ensure that no pay and allowances are claimed in respect of the unauthorized absences for the period of unauthorized absence and disciplinary action under CCS (CCA) Rules, 1965 may be initiated against them.
- A report of the absentees should be furnished on or before 08.05.2017 in the Proforma enclosed.
