CIRCULAR

Sub: Observance of Mass Leave and Picketing on 15th November 2018 by certain section of employees - Disciplinary action - Reg.

It is brought to the notice that a section of employees have proposed to observe Mass Leave and Picketing on 15th November 2018 to press the Charter of Demands.

2. In this connection attention is drawn to Rule 7(ii) of CCS (Conduct) Rules, 1964 which clearly stipulates that no Government servant shall resort to any form of strike or coercion or physical duress in connection with any matter pertaining to his service or the service of any other Government servants. As per Government of India's decision (2) below Rule 7, mass absenteeism from work without permission is tantamount to 'strike' and any Government servant who resorts to such action mentioned above in violation of Rule 7 (ii) of CCS (Conduct) Rules, 1964 will be liable for disciplinary action. The unauthorized absence/strike of the employees shall be treated as break-in-service invoking the provisions of F.R.17-A.

3. All Heads of Departments/Offices are directed not to grant leave to any staff except under exceptional circumstances.

4. No pay and allowances shall be claimed in respect of the unauthorized absentees for the period of unauthorized absence. Disciplinary action under CCS (CCA) Rules, 1965 may also be initiated against them, wherever necessary.

5. A report of absentees should be furnished in the prescribed proforma through a special messenger/by fax by 12.00 noon of 15.11.2018 without fail.
