### NOTIFICATION

The Lieutenant-Governor, Puducherry, is pleased to amend "The Puducherry Casual Labourers (Engagement & Regularisation) Scheme, 2009" notified vide G.O.Ms.No.22 dated 27.02.2009 and published in the Extraordinary Gazette of Puducherry No.15 dated 27.02.2009 and amended vide G.O.Ms.No.38 dated 03.07.2014 published in Extraordinary Gazette of Puducherry No.76 dated 04.07.2014, for implementation in the Department of Personnel & Administrative Reforms (Personnel Wing) with immediate effect, namely:-

In the said scheme, for paragraph 14, the following shall be substituted, namely :-

"14.Depending upon the requirement, not more than 75% of vacancies arising in the appropriate erstwhile Group "D" posts (initial category) may be filled by absorption of full time casual labourers available in the List and not less than 25% of vacancies shall be filled by direct recruitment. The full time casual labourers shall also be eligible for competing for direct recruitment along with open candidates provided they possess required educational qualification. They will be entitled for necessary age relaxation if selected. In case of non-availability of sufficient number of daily rated engagements for filling up of 75% by absorption, then the Department may resort to fill up the said shortfall also through direct recruitment".
