ABSTRACT

Chief Secretariat– Department of Personnel & Administrative Reforms (Personnel Wing) – Extending the benefits of CCS (Pension) Rules, 1972 (now 2021) to the Government Servants presently covered under National Pension System, whose appointment was made against a post or vacancy, which was advertised/notified for recruitment or by appointment through absorption prior to the date of notification for National Pension System i.e., 22.12.2003 – Orders – Issued.


ORDER:

The Government of India have decided that in all cases where the Central Government Civil employee has been appointed against a post or vacancy which was advertised/notified for recruitment, appointment, prior to the date of notification for National Pension System i.e., 22.12.2003 and is covered under the National Pension System on joining service on or after 01.01.2004, may be given a one-time option to be covered under CCS (Pension) Rules, 1972 (now 2021) and accordingly, instructed to exercise such option by the concerned Government Servants latest by 31.08.2023, which is final, as per the terms and conditions stipulated in the Office Memorandum first read above.

2. Accordingly, this Department had received the representation based on the options exercised by 54 Nos. of Government Servants before the last date of 31.08.2023 for switching over from National Pension System to Old Pension Scheme. On scrutiny of the applications received from the Government Servants, who have joined in Government service after 01.01.2004, based on the process for appointment on absorption initiated before 22.12.2003, the Government Servants, whose names are mentioned in the Annexure-I & II and who were already covered under National Pension System, are found eligible to switch over to pension scheme under of CCS (Pension) Rules, 1972 (now 2021), in accordance with the conditions stipulated in the Office Memorandum read above.

3. Accordingly, approval of the Hon'ble Lieutenant Governor of UT of Puducherry is conveyed to switch over the Government Servants, whose names are mentioned in the Annexure, from National Pension System to the pension scheme under CCS (Pension) Rules, 1972 (now 2021), subject to the following conditions:-

- i. The National Pension System account of the Government Servants shall be closed w.e.f. 31.12.2023 and they shall be required to subscribe to the General Provident Fund.

- ii. The employees' contribution in the National Pension System account shall be credited to individuals' GPF account and the account will be re-casted permitting up-to-date interest vide FR-16 & Rules 11 of GPF Rules.
- iii. The adjustment of Government contribution under National Pension System shall be made by proposing necessary transfer entries as follows:-

(-) Debit

To object head "70 – Deduct – Recoveries under Major Head – 2071 – Pension and other Retirement benefit – Minor Head 911 – Deduct Recoveries of over payment (vide GAR 35 and para 3.10 of list of Major and Minor Head of Accounts).

- iv. The adjustment of increased value of subscription on account of appreciation of investments will be accounted by crediting the amount to Government account under Major Head "0071 – Contribution towards Pension and other Retirement benefits – 800 – Other Receipts" (Note under the above Head in LMMHA).
 - v. The case of the Government servant mentioned in the annexure may be settled by the concerned Department, Puducherry in accordance with the instructions contained in the Office Memorandum read above.
4. This issues with the concurrence of the Finance Department, Puducherry vide I.D.Note No.1246/FC/FD/F3/A2/2023-24 dated 22.12.2023 and I.D.Note No.1291/FD/F3/FC/2023-24 dated 26.12.2023.
