In case it is found that the individual was guilty of misconduct involving moral turpitude, which would disqualify her for Government service, or had suppressed any material fact relating to her conduct prior to entry into Government service or if any declaration given or information furnished by her proves to be false, she will be liable to be discharged from service and such other action as Government may deem necessary.

5. As no person professing a religion different from the Hindu or Sikh religion can be deemed to be a member of Scheduled Caste, the candidate should inform about the change, if any, of her religion to the appointing/administrative authority immediately after such a change if she belongs to SC community.

6. If the candidate accepts this offer of appointment on the above term she should communicate her acceptance and report for duty before the Head of Department concerned **on or before 17.06.2022.** If no reply is received or the candidate fails to report for duty by the prescribed date, the offer will be treated as cancelled.

7. No travelling allowance will be allowed for joining the post.
