
ORDER:

The Service Associations have demanded for amalgamation of the posts of Superintendent Grade-I and Superintendent Grade-II and their re-designation as Superintendent in the pay scale of Rs.6,500-200-10,500 on par with the staffing pattern in the Government of India and the hierarchy in the Government of National Capital Territory of Delhi. The demand of the Service Associations has been examined in depth by the D.P. & A.R. and found that the level of responsibilities and duties attached to the two grades of Superintendent are one and the same and that the merger of both these grades amounts to rationalization of the hierarchy in the Ministerial cadre on par with that of the Government of India and the Government of National Capital Territory of Delhi. The Cabinet has also recommended the amalgamation of both the posts of Superintendent Grade-I and Superintendent Grade-II and the consequent re-designation of these posts as Superintendent in the pay scale of Rs.6,500-200-10,500.

2. Accordingly, the Lt. Governor, Pondicherry is pleased to accord approval to the amalgamation of both the posts of Superintendent Grade-I in the pay scale of Rs.6,500-200-10,500 and Superintendent Grade-II in the pay scale of Rs.5,500-175-9,000 as a single post in the designation of **SUPERINTENDENT** (Group 'B' Gazetted) in the pay scale of Rs.6,500-200-10,500 with effect from 01.01.1996 in accordance with the instructions contained in the Office Memorandum read above.

3. This issues with the concurrence of Finance Department vide their I.D. No. 8293/2006/F3 dated 7.1.2006.
