## Insbusy NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with the Government of India, Ministry of Home Affairs, Notification No. F5/4/65-GP, dated 11th January 1965, the Lieutenant-Governor, Puducherry, hereby makes the following rules regulating the method of recruitment to the Group 'C' post of Room Attendant in the Puducherry Government Guest House, Chennai, Puducherry viz.,

- 1. Short title and commencement.— (i) These rules may be called the Government of Puducherry, Chief Secretariat (Establishment), Group 'C' post of Room Attendant (Puducherry Government Guest House, Chennai) Recruitment Rules, 2015.
  - (ii) They shall come into force on and from the date of their publication in the official gazette.
- 2. Number of post, its classification and Pay Band and Grade Pay / Pay Scale.— The number of the said post, its classification and the Pay Band and Grade Pay / Pay Scale attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed hereto.
- 3. Method of recruitment, age-limit and other qualifications.— The method of recruitment to the said post, age-limit, qualifications and other matters relating thereto, shall be as specified in columns (5) to (13) of the said Schedule.
- 4. Disqualifications. No person, -
- (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Lieutenant-Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax.— Where the Lieutenant-Governor is of the opinion that it is necessary or expedient to do so, he may, by order, and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving.— Nothing in these rules shall affect the reservation, relaxation in upper age-limit and other concessions required to be provided for the scheduled castes, the scheduled tribes and other special categories of persons under the orders issued by the Government from time to time in this regard.
