



 Sir,

I am directed to inform that the DoPT vide O.M. No.14015/27/2021-AIS(I) dated 16.08.2021 has determined 05 promotion quota vacancies for promotion of SCS officers to the IAS of Joint AGMUT Cadre (UT Segment) for the Select List of 2020.

2. In terms of extant provisions under the IAS (Appointment by Promotion) Regulations, 1955, the Committee shall consider the cases of members of the State Civil Services in order of seniority in that service of a number which is equal to three times the number of vacancies. Therefore, the cases of **15 officers** for the Select List year 2020 are required to be placed before the Committee for consideration, subject to the exception on ground of age limit, willingness, vigilance status etc.

3. In order to prepare the Common Eligibility List (CEL) of 15 officers of DANICS and PCS (**Annexure-I**), their *seniority in JAG-I, JAG-II* or the equivalent grade as on 01.01.2020 together with *merit in Civil Service Examination for relevant years have been taken into consideration.*

4. A copy each of the **CEL (Annexure-I)** and the list of officers who have been excluded from the draft **CEL** for the Select List Year 2020 for the reasons mentioned against their name (**Annexure-II**), are enclosed. It is requested that this letter and also both the Annexures may be uploaded on the website of your office wherever the officers concerned are working. These documents are also being uploaded on the website of the MHA, i.e. [https://mha.gov.in/division\\_of\\_mha/Union\\_Territories\\_Division/circular](https://mha.gov.in/division_of_mha/Union_Territories_Division/circular).

5. It is requested that if any officer has any objection on **Annexure-I & Annexure-II**, the same may please be submitted to the undersigned on or before closing of office hours on 10.10.2021. The objections received in your office may also please be forwarded along-with comments to the undersigned within same timeframe. The objections received after closing of office hours on 10.10.2021, shall not be entertained.
