C I R C U L A R

Sub: Wearing of helmets by Government Servants – Reg.


In order to ensure public safety and to strictly enforce the practice of wearing helmets while driving two wheelers, the Government of Puducherry have notified compounding fee for various offences and authorized the officers of the Police, Transport and Revenue Departments to impose spot fines for "compoundable offences" that do not require adjudication of the courts. A copy of the notification is enclosed herewith.

Now, riding without a helmet will attract a spot fine of Rs.1,000/- under Section 194D and lead to disqualification from holding license for three months for first offence with a similar penalty for the second/ subsequent offences.

All the Government servants are, therefore, requested to wear helmets without fail. This is in the interest of their personal safety. One is liable for penalty of Rs.1000/- for not wearing helmet.

This may be brought to the notice of all officials including those working in PSUs/ Corporations/ Autonomous bodies/ Societies. All Administrative Secretaries/ Director General of Police/ Heads of Departments shall ensure strict compliance.

NOTIFICATION

In exercise of the powers conferred by sub-section (1) of section 200 of the Motor Vehicles Act, 1988 (Central Act No. 59 of 1988) and in supersession of the Notification issued under G.O. Ms. No. 17/Tr. Sectt./2015, dated 20th August 2015 of the Transport Secretariat, Government of Puducherry and published in the Gazette of Puducherry No. 34, dated 25th August, 2015, save as respects things done or omitted to be done before such supersession, the Lieutenant-Governor, Puducherry, hereby specifies that the offences punishable under sections mentioned in column (3) of the Table (A) below, in respect of all category of vehicles, may either before or after institution of prosecution be compounded by the officers as mentioned in Table (B) below as specified herein for the amount specified in the corresponding entries under column (4) or (5) as the case may be, of the Table (A), namely:-
