NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with the Notification No. F.5/4/65-GP, dated 11th January, 1965 of the Ministry of Home Affairs, Government of India, New Delhi and in supersession of the notification issued in G.O. Ms. No. 3/Tourism/2000, dated 20th March 2000 of the Department of Industrial Development (Tourism), in so far as the Schedule relating to the post of Electrician in the O/o the Resident Commissioner, Puducherry House, New Delhi is concerned save as respects things done or omitted to be done before such supersession, the Lieutenant Governor, Puducherry, hereby makes the following rules, regulating the method of recruitment to the post of Electrician in the Puducherry Government Guest House, New Delhi namely:-

1. *Short title and commencement.*— (i) These rules may be called O/o the Resident Commissioner, Puducherry House, New Delhi, Group 'C' post of 'Electrician' Recruitment Rules, 2025.

(ii) They shall come into force from the date of issue and date of their publication in the Official Gazette.

2. *Number of posts, its classifications and Level in the Pay Matrix* — The number of the said posts, its classification, and the Level in the Pay Matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed hereto.

3. *Method of recruitment, age - limit and other qualifications.*— The method of recruitment to the said posts, age limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the said Schedules.

4. *Disqualifications* . — No person, —

(a) who has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said posts:

Provided that the Lieutenant – Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

5. *Power to relax* --- Where the Lieutenant – Governor, is of the opinion that it is necessary or expedient so to do, he/she may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

6. *Saving* --- Nothing in these rules shall affect the reservations, relaxations in upper age- limit and other concessions required to be provided for the scheduled castes, the scheduled Tribes and other special category of persons in accordance with the orders issued by the Government from time to time in this regard.

RECRUITMENT RULES FOR THE POST OF ELECTRICIAN
IN PUDUCHERRY GOVERNMENT GUEST HOUSE, NEW DELHI

1.	Name of the Post	:	Electrician
2.	Number of Post	:	1 (One) (2025) Subject to variation dependent on work-load.
3.	Classification	:	General Central Services – Group 'C' – Non – Gazetted – Non – Ministerial.
4.	Level in the Pay Matrix	:	Level – 2 in the Pay Matrix (Pre-revised PB-1 ₹5,200–20,200 + Grade Pay of ₹1,900)
5.	Whether selection or non-selection post	:	Not-selectin
6.	Age limit for direct Recruits	:	Between 18 to 30 years of age (Relaxable for Government servants up to 40 years in accordance with the instructions or orders issued by the Central Government. Note : The crucial date for determining the age-limit shall be advertised by the Competent Authority
7.	Educational and other qualifications required for direct recruits	:	Essential: (i) A pass in S.S.L.C. or its equivalent; and (ii) Two years ITI certificate in the trade of Electrician/ Wireman issued by the Ministry of Labour and Employment, Government of India. Note: Qualification is relaxable at the discretion of the Competent Authority for reasons to be recorded in writing, in the case of candidates otherwise well qualified.
8.	Whether age and educational qualifications prescribed for direct recruits will apply in the case of promotes	:	Age : No Educational Qualifications : Yes
9.	Period of probation, if any	:	Two years for direct recruits Note: Direct recruits would be required to successfully complete a mandatory induction training of at least two weeks duration, as prescribed by the competent authority, for completion of probation.
10.	Method of recruitment whether by direct recruitment or by promotion or by deputation/absorption and percentage of the vacancies to be filled by various methods.	:	By promotion, failing which by direct recruitment.
11.	In case of recruitment by promotion/deputation/absorption, grades from which promotion/deputation/absorption is to be made	:	Promotion MTS (General) with 3 years of regular service rendered after appointment thereto on a regular basis and have successfully completed the training in in the trade of Electrician/ Wireman.

		Note – 1: The requirement of training for promotion is not applicable to the officials holding the feeder post in regular basis on the date of notification of these rules. Note-2: Where juniors who have completed their qualifying / eligibility service are being considered for promotion, their seniors should also be considered provided they are not short of the requisite qualifying / eligibility service by more than half of such qualifying / eligibility service or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying/ eligibility service.
12.	If a Departmental Promotion Committee/Recruitment Committee exists what is its composition?	: Department Confirmation Committee/ Recruitment Committee:- (1) Secretary (Personnel) - Chairman (2) Resident Commissioner, PGGH, New Delhi. - Member (3) Addl./ Joint/ Deputy Resident Commissioner, PGGH, New Delhi. - Member (4) Under Secretary (DP&AR) - Member
