The proposals cleared by the Screening Committee shall be submitted to the Chief Electoral Officer, along with full details and a note on urgency.
- 4. All the Heads of Departments/PSUs shall refer proposals attracting Model Code of Conduct, if any, to the Screening Committee through their Administrative Secretariat. No direct reference to the Chief Electoral Officer / Election Commission of India shall be made under any circumstances.
