NOTIFICATION

No.154/PUDU/2019-P. Admin: - In exercise of the powers conferred by sub-section (1) of section 13A of the Representation of the People Act, 1950 (43 of 1950), the Election Commission of India in consultation with the Government of Puducherry hereby nominates **Sh. Shurbir Singh, I.A.S.**, (AGMUT:2004) as the Chief Electoral Officer for the U.T. of Puducherry with effect from the date he takes over charge and until further orders in place Dr. V. Candavelou.

2. **Sh. Shurbir Singh, I.A.S.**, shall cease to hold and hand over forthwith the charge of all or any charges of work under the Government of Puducherry, which he may be holding before such assumption of office.

3. **Sh. Shurbir Singh, I.A.S.**, while functioning as the Chief Electoral Officer, Puducherry, shall not hold any additional charge whatsoever under the Government of Puducherry except that he should be designated Secretary to the Government in charge of Election Department in the State Secretariat.
