

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India read with the Notification No.F.5/4/65-GP dated 11th January 1965 of the Ministry of Home Affairs, Government of India, New Delhi, and in supersession of the Notification issued in G.O. Ms. No.38, dated 9th April 1991 of the Department of Personnel & Administrative Reforms (Personnel Wing), Puducherry and published in the Supplement to the Gazette No. 19 dated 7th May 1991 for the post of Superintendent Grade-I and the Notification issued in G.O. Ms. No.85, dated 16th September 1991 of the Department of Personnel & Administrative Reforms (Personnel Wing), Puducherry and published in the Supplement to the Gazette No.40 dated 1st October 1991 for the post of Superintendent Grade-II, save as respects things done or omitted to be done before such supersession, the Lieutenant Governor, Puducherry hereby makes the following rules regulating the method of recruitment to the post of Superintendent in the Government of Puducherry namely:-

Short title & Commencement:

(1) These rules may be called the Government of Puducherry (Superintendent) Recruitment Rules, 2019.

(2) They shall come into force on and from the date of their publication in the Official Gazette.

2. Number of Post, its classification and Level in the Pay Matrix:-

The Number of the said posts, its classification and Level in the Pay Matrix attached thereto, shall be as specified in Columns 2 to 4 of the Schedule annexed hereto.

3. Method of Recruitment, age limit and other qualifications :

The method of recruitment to the said post, age limit, qualifications and other matters relating thereto, shall be as specified in columns 5 to 13 of the said Schedule.

4. Disqualification :- No Person

(a) who has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Lieutenant Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax:-

Where the Lieutenant Governor is of the Opinion that it is necessary or expedient so to do, he/she may, by order and for reasons to be recorded in writing and in consultation with the UPSC, relax any of the provision of these rules with respect to any class or category of persons.

6. Saving :

Nothing in these rules shall affect the reservations, relaxation in upper age limit and other concessions required to be provided for the Schedule Castes and Scheduled Tribes in accordance with the orders issued by the Government from time to time, in this regard.


