In the Office Memorandum first cited above, the DoPT, Govt. of India has instructed to ensure that the following conditions are complied with while implementing the policy of reservation in promotion as set out by Hon'ble Supreme Court in Jarnail Singh and Ors. V. Lachhmi Narain Gupta and Ors. (Civil Appeal No. 629 of 2022) case:

- (i) Collection of quantifiable data regarding inadequacy of representation of Scheduled Castes and Scheduled Tribes;
- (ii) Application of this data to each cadre separately; and
- (iii) If a roster exists, the unit for operation of the roster would be the cadre for which the quantifiable data would have to be collected and applied in regard to the filling up of the vacancies in the roster.
- 2. Following this, the Department of Personnel and Administrative Reforms (Personnel Wing), Puducherry sought for clarification from the Ministry of Home Affairs, Government of India regarding the procedure to be followed while effecting reservation in promotion i.e. whether the SC officials who got promotion on their own merit are to be taken into account to determine the adequacy of representation of SC in a cadre (or) whether the inadequacy of SC in a cadre is to be determined excluding the own merit SC officials and taking into account only those who got promotion as per their quota.
- 3. Now, the Ministry of Home Affairs has conveyed the clarification given by the DoPT, Government of India which is enclosed herewith for guidance and strict compliance of all the Secretariat Departments / Cadre Controlling Authorities.

4. It shall be ensured that the recommendations made by DPC held from the date of issue of the O.M. cited above to till date were in accordance with the clarification issued now, and deviations if any may be reviewed and set right immediately. A compliance report shall be sent to this Department.

- With regard to the specific query of GoP, attention is invited to the observations of Hon'ble Supreme Court in para 17 of its judgement dated 28.1.2022, which is relevant to the query. In this para, Hon'ble Supreme Court has referred to the Sabharwal judgement in which the issue/point of own merit was one of the matters of dispute. Hon'ble Supreme stated that in Sabharwal judgement, it was held, "....reserved category candidates can compete for non-reserved posts and in the event of their appointment to the said posts, their number cannot be added and taken into consideration for working out the percentage of reservation. Accordingly, the Hon'ble Supreme Court, vide its aforesaid judgement dated 28.1.2022 has held, 'The percentage of posts reserved for Backward Classes, as prescribed by the State, has to be strictly followed and cannot be varied or changed simply because some members of the Backward Class have already been appointed/promoted against the general seats."
- 1. However, since the Jarnail Singh batch of cases is still pending in the Hon'ble Supreme Court of India, the OM dated 12.04.2022 provides that any promotion order issued shall be subject to further orders that may be passed by the Supreme Court in the said batch of cases. In view of the above, GoP may take further action accordingly.
