Subsequently, the Chief Vigilance Office issued vigilance clearance to him vide I.D.Note, dated 01.04.2010 2nd cited as was exonerated from all charges framed against him vide Order dated 7.3.2006. Later he was promoted as Superintendent vide Memo. dated 29.06.2010 third cited.

- 2. The review DPC held by circulation, recommended the said Thiru N. Azhagarselvam, for promotion to the post of Superintendent on ad-hoc basis notionally w.e.f. 26.02.2010 on par with his junior Thiru K. Ramadoss and with monetary benefit from 07.07.2010, the date from which he actually joined the post of Superintendent. Further the said Review DPC has also recommended to fix his seniority in the post of Superintendent above Thiru K. Ramadoss, Superintendent, retired.
- 3. Accordingly, Thiru N. Azhagarselvam, Superintendent, retired (Assistant Sen.No.1195) is promoted to the post of Superintendent on notional basis w.e.f. 26.02.2010 i.e. the date of joining of his junior Thiru K. Ramadoss (Assistant Seniority No. 1199) Assistant to the post of Superintendent with monetary benefit from 07.07.2010, the date from which he actually joined the post of Superintendent. His seniority in the post of Superintendent would be fixed above Thiru K. Ramadoss, Superintendent, retired.
