**MEMORANDUM**

Sub: Public Services – Promotion and posting of Thiru P. Aroune,  
Lower Division Clerk as Upper Division Clerk – Orders – Issued.

Wing), Puducherry.

Thiru P. Aroune, LDC, Chief Secretariat, Puducherry was not considered for promotion to the post of UDC in the DPC held on 21.08.2013 alongwith his juniors, as his probation in the post of LDC was not declared by that time. As his probation has been declared with effect from 09.10.2010, after obtaining special relaxation vide Government order cited under reference.

2. The DPC held on 16.12.2015 has recommended Thiru P. Aroune, LDC, Chief Secretariat, Puducherry for promotion to the post of UDC on ad-hoc basis notionally with effect from 22.08.2013 on par with his junior Tmt. A. Anandarasi, UDC and with monetary benefit from the date of actual joining in the promotional post of UDC.

3. Accordingly, Thiru P. Aroune, LDC, Chief Secretariat, Puducherry is promoted as Upper Division Clerk on ad-hoc basis notionally with effect from 22.08.2013 on par with his junior Tmt. A. Anandarasi, UDC and with monetary benefit from the date of actual joining in the promotional post of UDC and he is posted in the Adi-dravidar Welfare Department, Puducherry vice Thiru K. Sivanandam, UDC deputed.

4. He will draw pay in the pay band of Rs.5200-20200 with grade pay of Rs.2400/- plus usual allowances as admissible under rules.

5. The DPC has also recommended to fix the seniority number of Thiru P. Aroune, (LDC Seniority No.4861) in the post of UDC above Tmt. A. Anandarasi (LDC Seniority No.4862).

6. The official is directed to report for duty **on or before 18.01.2016**, failing which it will be presumed that he has declined the promotion offered to him and he will not be considered for promotion for a period of one year or next DPC, whichever is later, from the date of receipt of the promotion order.
