**MEMORANDUM**

Sub: Public Services - Promotion and posting of Thiru. R. Deivanayagam, Lower Division Clerk as Upper Division Clerk - Orders - Issued.

Ref: G.O.Ms. No.14 dated 12.03.2015 of the DP&AR(Personnel Wing), Puducherry.

Thiru R. Deivanayagam, LDC, Police Department, Puducherry was not considered for promotion to the post of UDC in the DPC held on 21.08.2013 alongwith his juniors, as his probation period in the post of LDC was not declared by that time. Later, the probation period has been declared with effect from 09.10.2010, after obtaining special relaxation vide Government order cited under reference.


2. The DPC held on 16.12.2015 has recommended Thiru R. Deivanayagam, LDC, Police Department, Puducherry for promotion to the post of UDC on ad-hoc basis with notional effect from 22.08.2013 on par with his junior Thiru. Kona Gangadhara Rao, UDC and with monetary benefit from the date of actual joining in the promotional post of UDC.

3. Accordingly, Thiru R. Deivanayagam, LDC, Police Department, Puducherry is promoted as Upper Division Clerk on ad-hoc basis with notional effect from 22.08.2013 on par with his junior Thiru. Kona Gangadhara Rao, UDC and with monetary benefit from the date of actual joining in the promotional post of UDC and he is posted in the Police Department, Puducherry vice Thiru R.V. Ezhilan, UDC promoted.

4. He will draw pay in the pay band of Rs.5200-20200 with grade pay of Rs.2400/- plus usual allowances as admissible under rules.

5. The DPC has also recommended to fix the seniority number of Thiru. R. Deivanayagam (LDC Seniority No.4810) in the post of UDC above Thiru. Kona Gangadhara Rao (LDC Seniority No.4811).

6. The official is directed to report for duty **on or before 18.01.2016**, failing which it will be presumed that he has declined the promotion offered to him and he will not be considered for promotion for a period of one year or next DPC, whichever is later, from the date of issue of this order.
