S.Nirmala Arokiomary (UDC Seniority No.3639) and with monetary benefit from the date of actual joining in the post of Assistant. Consequently, his seniority in the post of Assistant is also fixed in between Thiru G.M.Saravanan (UDC Seniority No. 3637) and Tmt. S.Nirmala Arokiomary (UDC Seniority No.3639).
- 4. On promotion, D.Djeacoumare, UDC is posted in the Directorate of Accounts and Treasuries, Puducherry vice Thiru C.Shiam Sundar, Assistant, transferred earlier.
