ORDER

Sub: Public Services – Grant of notional Promotion to the post of Superintendent to Thiru V.A. Vinayaraj, Superintendent, Retired – Orders – Issued.

Thiru V.A. Vinayaraj, Superintendent, Retired, had been earlier promoted to the post of Superintendent Gr-II and posted in the Police Dept., Puducherry vide Memo. dated 27.05.2005 1st cited. However, the promotion order was cancelled vide Memo. dated 14.7.2005 2nd cited as he declined the promotion and proceeded to the deputation post of Sub-Registrar in Mahe. As per rule a candidate who declined promotion, may be considered after one year from the earlier DPC date or in the next DPC, which ever is later. The DPC conducted on 25.02.2010 for promotion to the post of Superintendent, the name of Thiru V.A. Vinayaraj was erroneously omitted and later he was promoted as Superintendent vide Memo. dated 29.06.2010 third cited.

2. The review DPC held by circulation, recommended the said Thiru V.A. Vinayaraj, for promotion to the post of Superintendent on ad-hoc basis notionally w.e.f. 26.02.2010 on par with his junior Tmt. P. Radha and with monetary benefit from 02.07.2010, the date from which he actually joined in the post of Superintendent. Further the said Review DPC has also recommended to fix his seniority in the post of Superintendent above Tmt. P. Radha, Superintendent, retired.

3. Accordingly, Thiru V.A. Vinayaraj, Superintendent, retired (Assistant Sen.No.1028) is promoted to the post of Superintendent on notional basis w.e.f. 26.02.2010 i.e. the date of joining of his junior Tmt. P. Radha (Assistant Seniority No. 1162) Assistant to the post of Superintendent with monetary benefit from 02.07.2010, the date from which he actually joined the post of Superintendent. His seniority in the post of Superintendent would be fixed above Tmt. P. Radha, Superintendent, retired.
