The results of the Limited Departmental Competitive Examination (LDCE) for the post of Assistant, held on 27.07.2025, were notified on 17.11.2025 vide reference cited. The approval of the Competent Authority was accorded on 31.12.2025 for the appointment of 70 UDCs selected through the said LDCE.

2. Since the Competent Authority has approved the appointments within the recruitment year, the 70 UDCs whose names are shown in the *Annexure* to this Memorandum are hereby appointed as Assistants notionally with effect from 31.12.2025 on ad hoc basis and are posted in the departments/offices noted against them. The monetary benefit will be from the actual date of joining in the post of Assistant.

3. They will draw pay in Level-6 of Pay Matrix plus other allowances as admissible under rules.

4. The officials shall report for duty on or before 30.01.2026, failing which it will be presumed that he/she has declined the offer and it will be treated as cancelled.

5. This ad-hoc appointment is subject to the outcome of the W.P.Nos. 38073, 38079, 37460, 37456, 37374, 40386, 40490, 40485, 40484, 41197, 41191, 41188, 40494, 40493 and 41195 of 2024 pending before the Hon'ble High Court of Judicature of Madras.
