

The officials shall report for duty and submit their joining report in the Department/Office itself where they are working at present and their salary shall be claimed against the existing vacant posts noted against their respective names, for the time being and until further orders. The officials at Sl. Nos. 4, 21 and 29 shall report to the parent Department from where they were deputed.

4. If they fail to report for duty on or before 10.01.2025, it will be presumed that they have declined the promotion offered and they will not be considered for promotion for a period of one year from the date of issue of this Memorandum.

5. This regular promotion is subject to the outcome of Jarnail Singh batch of cases in the Hon'ble Supreme Court of India.
