Thiru K.S. Srinivasan, UDC (LDC Seniority: 4868) was not considered for promotion to the post of UDC alongwith his juniors as his probation period was not declared due to non-passing of Accounts Test for Subordinate Officer (Part-I). Later, he was exempted from passing the said test and his probation was declared with effect from 21.02.2015 vide G.O. Ms. No.34 dated 31.07.2017 of the Health Secretariat, Puducherry. Hence, his case was considered in the DPC meeting held on 24.10.2019 and he was promoted as UDC on regular basis vide Memorandum dated 09.12.2019 and joined the post on 30.12.2019.

- As his probation was declared w.e.f. 21.02.2015 and he had completed more than 8 years of service as LDC as on 01.04.2016, he was eligible to be considered for promotion to the post of UDC for the vacancy year 2016-17 on par with his junior, Tmt. R. Parimala, UDC (LDC seniority: 4882) who was promoted as UDC vide Memorandum dated 17.08.2016. Therefore, his case was reviewed by the DPC.
- The review DPC after considering relevant facts and records has 3. recommended Thiru K.S. Srinivasan, UDC (Seniority in LDC: 4868) for notional promotion to the post of Upper Division Clerk on regular basis with effect from 22.08.2016 (i.e) the date of joining of his immediate junior Tmt. R. Parimala, UDC (LDC Seniority No. 4882 with monetary benefit from 30.12.2019 i.e. from the date of his actual joining in the post of UDC and to fix his seniority in the post of UDC above Tmt. R. Parimala, UDC.
- Accordingly, Thiru K.S. Srinivasan, UDC, Special Buildings Division-I, PWD, Puducherry is promoted to the post of UDC on regular basis notionally on par with his junior Tmt. R. Parimala, UDC, with effect from 22.08.2016 and with monetary benefit with effect from 30.12.2019. His seniority in the post of UDC shall be fixed above his junior Tmt. R. Parimala, UDC.
