Approval of Hon'ble Lt. Governor was obtained for grant of notional promotion to 142 UDCs, who had been actually promoted as UDC in 2011, with effect from 01.01.2009 by invoking the retention clause contained in para 3.1.3 of DoPT guidelines issued vide O.M. dated 18.03.1988. But, notional promotion was given to 121 UDCs only vide Memorandum second cited and the cases of the remaining UDCs were deferred for want of ACRs / declaration of completion of probation in the post of LDC.


2. Subsequently, on receipt of ACRs / declaration of completion of probation in the post of LDC, proposal for notional promotion to nine UDCs was placed before the DPC which approved it by circulation. Based on the recommendations of the DPC, the below mentioned UDCs are granted notional promotion to the post of UDC on regular basis with effect from date noted against each. However, they are entitled to monetary benefits only from the actual date of joining in the post of UDC.
