Superintendents on ad-hoc basis – Orders - Issued.



The Assistants mentioned in the Annexure to this Memorandum are promoted as Superintendent purely on ad-hoc basis and posted in the Departments/ Offices noted against them, with immediate effect.

2. The ad-hoc promotion is subject to the condition that if the DPC when meets for regular promotion finds the official unfit, he/she will be reverted and will have no claim for having officiated in the post of Superintendent on ad-hoc basis.

3. They will draw pay in the Level-7 of the Pay Matrix plus other allowances as admissible under rules.

4. The officials are directed to report for duty on or before 21.07.2017, failing which it will be presumed that he/she has declined the promotion offered and he/she will not be considered for promotion for a period of one year or next DPC, whichever is later, from the date of issue of this order.
