Thiru. R. Tirougnanassambandame, UDC, resigned the post of UDC on Technical formality and he was relieved with effect from the afternoon of 29.06.2020 from the National Highways Division, Public Works Department, Puducherry to take up appointment as Assistant Commercial Tax Officer in the Commercial Taxes Department, Puducherry.

- 2. The Additional Secretary to Government(CT) has informed that Thiru. R. Tirougnanassambandame, Assistant Commercial Taxes Officer who joined on 30.06.2020, submitted technical resignation on 30.07.2020 during his lien period and the same has been accepted. The Additional Secretary to Government(CT) has requested to revert the official to the parent cadre viz. UDC vide I.D.Note cited under reference.
- 3. The request of Thiru. R. Tirougnanassambandame, ACTO has been considered in light of the provisions contained in FR 13 read with Govt. of India's Orders thereunder which stipulates that in the case of permanent Government servants, their lien may be retained in the parent Department for a period of two years, in exceptional cases, be permitted to retain the lien in the parent Department for one more year.
- 4. Since the said official was appointed substantively in the entry grade of LDC and holds Lien on the post of UDC, approval of the Secretary to Government(Personnel) is accorded to revert Thiru. R. Tirougnanassambandame, ACTO to rejoin the post of UDC. Accordingly, Thiru. R. Tirougnanassambandame is reverted to his parent cadre post of UDC and posted in the Directorate of Agriculture and Farmers Welfare, Puducherry vice Thiru. E.D. Manikandan, UDC transferred, with immediate effect.
- 5. The above official is not entitled for joining time/transfer T.A. as the reversion to his parent cadre is issued on his own request.
