ORDER:-

The following notification shall be published in the State Gazette.

NOTIFICATION

The substantive appointment to Grade-II of Pondicherry Civil Service made by this Administration vide G.O. Ms. No.30 dated 13.07.1999 and the subsequent seniority list published vide G.O. Ms. No.49 dated 30.06.2000 were challenged by some Pondicherry Civil Service officers in the Central Administrative Tribunal, Chennai Bench, in O.A. No.542, 896/1999 and in a batch of cases. The Central Administrative Tribunal vide its order dated 01.05.2001 quashed the aforesaid Government orders i.e., G.O. Ms. No.30 dated 13.07.1999 and G.O. Ms. No.49 dated 30.06.2000. This Administration preferred appeal in the High Court of Judicature Madras against the said Central Administrative Tribunal's order.

2. The Hon'ble High Court dismissed the Writ Petitions No.26513 to 26515/2001 and a batch of cases vide its order dated 03.01.2005 and directed the Government of Puducherry (Petitioner) as under: -

"Further, courts have held that when the promotees have been promoted on ad hoc basis and for no fault of them, their services have not been regularised, and their length of services on ad hoc appointments, cannot be ignored. But this is subject to availability of posts towards their quota. That means if their appointments are made within their quota provided by the Rules, their services can be taken from the date of their appointments. The Tribunal quashed the GO Ms. No.30 dated 13.07.1999 on the ground that retrospective relaxation is not possible, though the Tribunal found that the ad hoc services can be regularised. As already stated, it cannot be said that there cannot be any retrospective relaxation. Regularisation can be done retrospectively subject to availability of posts towards their quota.

So, the relief No.(1) granted in paragraph 62 of the order of the Tribunal, preventing the Government from granting retrospective relaxation, cannot be sustained. But, such relaxation should be made within the 50% of substantive vacancies available in a particular year towards the promotees quota, after taking into consideration the ad hoc appointments of the promotees, who had already retired but worked in a particular year."

3. In pursuance of the aforesaid High Court order dated 03.01.2005 a fresh exercise on substantive appointment to Grade-II of PCS under promotion quota from the year 1992 to 2006 was undertaken by this Administration, taking into account the ad-hoc appointment of retired officers also, in consultation with the Union Public Service Commission, New Delhi. Based on the recommendations of the Selection Committee headed by Chairman/ Member of UPSC, substantive appointments to Grade-II of PCS under promotion quota from the year 1992 to 2006 have been made vide G.O. Ms. No.27 dated 05.05.2008 and G.O. Ms. No.93 dated 25.09.2008.

4. Following the above substantive appointments to Grade-II of PCS, the tentative seniority list of PCS officers appointed both under direct recruitment quota and promotion quota was circulated to all concerned calling for objections, if any, vide Memorandum read above. Accordingly, objections were received from few serving and retired PCS officers and the same were examined carefully. After careful scrutiny, the objections were found to be lacking in substance and were finally disposed of as having no merits.

5. Therefore, the final seniority of the officers regularly appointed to Grade-II of Pondicherry Civil Service from the year 1992 to 2006 shall be as under: -
