NOTIFICATION

The tentative inter-se seniority list of officers holding the Schedule-II post of Pondicherry Civil Service was circulated vide Office Memorandum read above inviting objections, if any, to the inter-se seniority assigned to the officers.

- 2. Meanwhile, Thiru S. Mohandass, Deputy Director, Tourism Department, Puducherry challenged the above tentative inter-se seniority in the Central Administrative Tribunal, Madras Bench in O.A. No.715/2009. The Central Administrative Tribunal while disposing the O.A., has passed orders directing this Administration to provisionally include the name of Thiru S. Mohandoss in the inter-se seniority list of Schedule-II officers pending final approval of the draft amendments to PCS Rules by the Government of India, as a similar post of Assistant Director in the Information & Publicity Department has already been included in the Schedule-II of PCS.
- 3. This Administration has already proposed to include the post of Assistant Director/ Deputy Director (Tourism) under Schedule-II of PCS and necessary amendments to PCS Rules have been submitted to Government of India and the approval is awaited. Similarly, the post of Assistant Director (Administration/ Common Service)/ Commissioner Grade-I of Local Administration Department and the post of Tahsildar of Elections Department have also been proposed to be included under Schedule-II as per the amendments proposed. Therefore, with a view to ensuring uniformity and fairness, the names of the eligible incumbents of the above posts that are proposed to be included under Schedule-II of PCS including Thiru S. Mohandass, Deputy Director (Tourism) have been provisionally included in this final seniority of Schedule-II posts pending approval of Government of India.

4. Therefore, after carefully examining all the objections received, the final inter-se seniority of officers holding Schedule-II posts of Pondicherry Civil Service upto the year 2005 is as indicated below:
