**MEMORANDUM**

Sub: Public Services – Circulation of tentative seniority list of Stenographer Gr.I.

- Ref: 1. This Department's G.O.Ms.No.11/DP&AR(PW)/SS.II(1) dated 01.03.2011.  
2. This Department's G.O.Ms.No.30/2012-DP&AR, dated 22.03.2012 issued vide Supplement to the Gazette No.13 dated 27.03.2012.  
3. Office Memorandum No.20020/4/2010-Estt.(D) dated 13.09.2012 of Dept. of Personnel & Training, Ministry of Personnel, Public Grievances and Pensions, Govt. of India.  
4. This Department's G.O. Ms. No.73/2019-DP&AR/SS.II(1) dated 08.11.2019.

The post of Stenographer Gr.I and the post of Stenographer Gr.II in the pre-revised scales of ₹5500-9000 and ₹5000-8000 respectively were merged on the recommendations of the Sixth Central Pay Commission and re-designated as Stenographer Gr.I in the pay structure of PB2 with Grade Pay ₹4200/- vide G.O. 1<sup>st</sup> cited under reference.

2. Subsequently, the Recruitment Rules for the post of Stenographer Gr.I was notified vide reference 2<sup>nd</sup> cited.

3. As per the Office Memorandum issued by Govt. of India vide reference 3<sup>rd</sup> cited, "where all the posts in one or more pre-revised scales are merged with a higher pre-revised scale and given a common replacement scale/grade pay/pay scale, the suitability of the incumbents need not be assessed for granting them the higher replacement scale/ grade pay/pay scale, there is also no need for the incumbents to complete any minimum eligibility service in the earlier scale of pay. There will be no change in the inter se seniority of the incumbents in the merged scale which shall be decided based on the general instructions on the subject".

4. Therefore, the 14 Stenographers mentioned in the Annexure to this Memorandum who were regularly appointed in the erstwhile post of Stenographer Gr.II are deemed to be regularly appointed in the merged post of Stenographer Gr.I with effect from 01.03.2011 i.e. the date of issue of G.O. first cited.

5. Therefore, in continuation of seniority list issued vide Government Order fourth cited, the tentative seniority to 14 Stenographers Gr.I is prepared as indicated in the Annexure to this Memorandum. Objections, if any, to the seniority assigned may be made to this Department on or before 24.01.2020.

6. If no objections are received by that date, it will be presumed that the Officials have nothing to represent and the Department will proceed to fix their seniority accordingly. If there is any change in the Department/Office against which they are shown as working, the same may be intimated to this Department.
