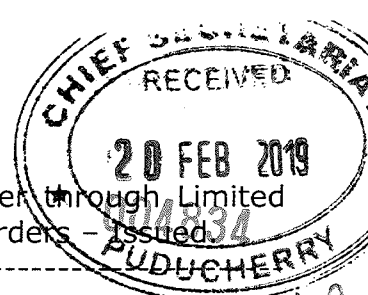

In supersession of the G.O. read above, consequent to the implementation of VAT Act and Rules, 2007 w.e.f. 01.07.2007 and Goods and Services Tax Act & Rules, 2017 w.e.f. 01.07.2017 in the U.T. of Puducherry, it is necessary that the revised syllabus of the examination is to be prescribed, so that the Limited Departmental Competitive Examination for the post of Assistant Commercial Tax Officer could be conducted as and when necessary.

2. Accordingly, approval of the Lieutenant Governor is accorded to prescribe the following revised syllabus, maximum marks, duration of the examination and type of the examination.
