MEMORANDUM

The undersigned hereby offer to the Home Guards mentioned in the 'annexure' to this memorandum, an offer of appointment as Watchman in the Department / Office indicated against each, on a pay of ₹4,440/ per month in the Pay Band of ₹4,440-7,440 with Grade Pay of ₹1,300/- purely on temporary and ad-hoc basis. He will also be entitled to draw the dearness and other allowances at the rates admissible and subject to the conditions laid down in the rules and orders governing the grant of such allowances in force from time to time.

2. The terms of appointment are as follows:-

i) the appointment is purely on temporary and ad-hoc basis and may be terminated at any time by a month's notice given by either side without assigning any reason. The Appointing Authority, however, reserves the right of terminating the services of the appointee forthwith or before the expiry of the stipulated period of notice by making payment to him a sum equivalent to the pay and allowances for the period of notice or the unexpired portion thereof.

ii) other conditions of service will be governed by the relevant rules and orders in force from time to time.

3. The offer of appointment is subject to the outcome of the court cases W.P. No.18615/2005, W.P. No.596/2006, W.P. No.10134/2009, W.P. No.14784/2009 and W.P. No.14894/2009.

4. The appointment will be further subject to -

i) production of records relating to date of birth.

ii) production of a certificate of fitness from the Competent Medical Authority (R.M.O.).


iii) submission of declaration in the form enclosed (Annexure-I) and in the event of the candidate having more than one wife living or being married to a person, having more than one wife living, the appointment will be subject to his being exempted from the enforcement of the requirement in this behalf.

iv) submission of attestation forms (Annexure-II) for verification of character and antecedents alongwith the joining report


5. In case it is found that he was guilty of misconduct involving moral turpitude, which would disqualify him for Government Service, or had suppressed any material fact relating to his conduct prior to entry into Government Service or if any declaration given or information furnished by the candidate proves to be false, he will be liable to be discharged from service and such other action as Government may deem necessary.

6. As no person professing a religion different from the Hindu or Sikh religion can be deemed to be a member of Scheduled Caste, the candidate should inform about the change, if any, of his religion to the appointing/administrative authority immediately after such a change if he belongs to SC community.

7. If the candidate accepts this offer of appointment on the above terms he should communicate his acceptance and report for duty before the Head of Department concerned on or before 18.01.2011. If no reply is received or the candidate fails to report for duty by the prescribed date, the offer will be treated as cancelled.
