Special Protection Group, established under an Act of Parliament, is entrusted with the responsibility of providing proximate security to the Prime Minister of India as well as former Prime Ministers and their family members. SPG is an entirely deputationist organization.

2. At present, SPG is facing shortage of 05 officers at the DIG level. There is also a need for inducting IPS officers at the level of SPs/SSPs.

3. I would be grateful, if nominations of suitable and willing IPS officers at the level of SP/SSP and DIG are forwarded to this office for consideration of their suitability in SPG. The officers at the DIG level must be empanelled to hold DIG level posts in the Centre. IPS officers inducted into SPG are eligible for Special Security Allowance (27.5% of Basic Pay, per month) in addition to Uniform Allowance @ Rs. 27,800/- per year.

4. You may consider impressing upon the DGP and eligible IPS officers in your State for sending nominations.
