- Organising operational research work on problems according to priorities laid down by SI (a) Directorate and ensuring their expeditions solutions and exploitation thereof.
- Organising basic research on problems of interest to SI Directorate and computerisation activities designed to assist operational and basic research.
- Supervising professional training to the officers and staff under him and organising/various training programmers.
- Guidance of the officers and the staff under him in their operational and basic research work.
- (e) The overall security, supervision and administration of the Research wing.
- The departmental officers in the feeder category who are in direct line of promotion will not be eligible for consideration for appointment on deputation and similarly, deputationists shall not be eligible for consideration for appointment by promotion.
- The Period of deputation including period of deputation in another ex-cadre post held. immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed five years. The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications. The appointment on deputation shall be governed by DOP&T OM No. 6/8/2009-Estt. (Pay-II) dated 17 Jun 2010 and its subsequent amendments, if any.
- For the purpose of appointment on deputation basis, the service rendered on a regular 5. basis by an officer prior to 1st January, 2006 or the date from which the revised pay structure based on the Sixth Central pay Commission recommendation has been extended shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Pay Commission, except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extend only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any upgradation.
