2. The last date of submission of application is 13th May, 2022, 5.00 PM. 3. Candidates who volunteer for the post will not be permitted to withdraw their names later on. Nominations should be accompanied by the requisite personal data as given in the application form, along with vigilance clearance, integrity certificate and attested copies of ACRs / Performance Report for the last five years. Those applications without the mandatory documents will not be considered. The curriculum vitae, duly supported by documents will be assessed by the Selection Committee while selecting the candidate for appointment to the post on deputation basis.

4. A Government servant holding post in higher level of pay will not be eligible to apply for the post in term of DoPT's OM referred to above.

It is requested that the vacancy may be given wide publicity and applications of eligible officials, who are willing to be considered and whose services can be spared immediately, if selected, may please be sent to the Under Secretary, Technology Development Board, Department of Science & Technology, Block-II, 2nd Floor, Technology Bhawan, New Mehrauli Road, New Delhi-110016, so as to reach TDB before the last date.
